RESOURCE Availability & MARKET for Sale



- Major food grain produced in the state is rice. Production of paddy, maize, wheat, Pineapple, Orange, Jackfruit, Banana, Litchi, Cabbage, Cauliflower, Okhra, Brinjal, Tomato and Production of Milk, Eggs, Meat & Fish are major resources available for Processing. Tripura being the gateway of North-East, Industrial Entrepreneurs can fetch raw material from Seven Sister North-Eastern States for setting pharmaceutical, spices, herbal industrial units.
- Processed Products that may be derived are Noodles, Flours (fortified), Biscuits & bakery, Breakfast cereals & Mixes, Flour, corn flakes, corn meal, corn oil, starch and its derivatives (like glucose, starch), juice, tidbit slice, Jam, Concentrates, IQF, Fibre Marmalade, Cocktail syrup, preserved fresh, wax emulsion, Dehydrated, Chips, Pulp in Syrup, Osmo- air dried and wax emulsion, Juice, Jam, Syrup, Concentrates, IQF, Fruit cocktail in Syrup, Puree, Chips, Pulp, Concentrates, Banana Powder, Juice, Jam, Concentrate, Marmalade, Fruits cocktail in syrup, preserved fresh, pharmaceutical, spices, packaged drinking water, aerated drinks & beverages, herbal tea packaging, ice cream, milk powder, dairy products, meat based products, fish based products, etc.
 - In Tripura, there are more than 600 (Daily, Weekly, Biweekly) agricultural markets of different sizes out of which 31 are daily markets. There are about 84 major wholesale markets in Tripura including 21 regulated markets.
 - ☐ Tripura and other North-Eastern States are having good population which is ready market for domestic consumption. Moreover, Tripura is surrounded by International Boundary facilitating high potentiality for export oriented industrial units.

RUPEES by way of TAX EXEMPTION for Setting Factory



Our Tripura State Government in association with Central Government has announced the following Incentives for Potential Investors:

- 100% Exemption from Payment of Excise Duty and Income Tax for 10 Years from the date of commercial production.
- Reimbursement of Commodity Taxes, subject to a ceiling of ₹ 50 Lakhs per year per unit.
- ☐ Income Tax Income Tax Exemption for 5 years for the new industrial units set up in the North-eastern region.
- □ Industrial Promotion Subsidy equal to the net amount (net of input taxes) of the Tripura Value Added Tax (VAT), Central Sales Tax (CST) and any other commodity tax actually paid by an enterprise to the State Government on sale of finished goods, subject to overall ceiling of ₹ 50 lakhs per enterprise per annum. The subsidy shall be given to an eligible enterprise for 5 years from the date of commercial production.

RUPEES by way of INCENTIVES/SUBSIDIES for Setting Factory



- ☐ 15% Procurement Preference would be provided to local Industrial enterprises after comparison on landed price of all bidders.
- ☐ Interest Subsidy on term loans @ 3%, subject to a ceiling.
- 90% subsidy on Air Freight from Agartala to Guwahati/Kolkata, on transport of fruits/fruit products for export.
- □ State Transport Subsidy @ 10% for transportation of raw materials and finished products between Siliguri and Factory site.
- □ State Government is providing a Police Assistance booth in our Mega Food Park to ensure security and safety of industries and workmen.
- ☐ State Government is providing a Fire brigade Station in our Tripura Mega Food Park to ensure efficient fire security of the industries. Thus fire clearances become easier as fire station lies within 1 Km. radius of our Mega Food Park.

RUPEES by way of **INCENTIVES/SUBSIDIES** for Setting Factory

- ☐ State Government is providing sub-station/ transformers to supply 24x7x365 uninterrupted power supply to the Mega Food Park and its industrial units (IUs) to ensure stable industrial development of Tripura.
- ☐ Reimbursement of Standard Certification charges/ fees/ expenses to eligible enterprises.
- Partial Reimbursement of Power Charges to the extent of 15% of the power charges actually paid by the enterprise, subject to a ceiling of ₹ 12 lakhs per enterprise per year. The incentive shall be given to an eligible enterprise for 5 years from the date of commercial production.
- ☐ Prompt and regular clearance of incentives and subsidy claims, both State and Central; State is up-to-date in payment/reimbursement of incentives and subsidies.
- ☐ Tripura Industrial Development Agency (TIDA), as Single Window for facilitation of necessary clearances and other assistance to entrepreneurs.

MAJOR TERMS & CONDITIONS for allotment of Plot @ ₹ 1/-

- Entrepreneur must start the construction activities of your proposed factory within 3 (three) months from the date of allotment of plot by Sikaria Mega Foodpark Private Limited.
- Entrepreneur are also required to start the commercial production within 18 (eighteen) months from the date of allotment of the said plot by Sikaria Mega Foodpark (P) Limited, unconditionally.
- On issue of allotment letter, a Bank Guarantee from a Scheduled Commercial Bank (calculated @ ₹ 40.00 lacs per acre) shall be provided in favour of Sikaria Mega Foodpark Private Limited for a period of 24 months from the date of allotment of land (as per specified format).
